AN ORDINANCE AMENDING DENALI BOROUGH CODE 2.15.030 TITLED REGULAR ASSEMBLY MEETINGS.

BE IT ENACTED BY the Assembly of the Denali Borough:

Section 1. Classification. This ordinance is of a general and permanent nature.

Section 2. DBC 2.15.030 is amended.

DBC 2.15.030 titled Regular assembly meetings shall be amended to as follows:

**CHAPTER 2.15**  
**ASSEMBLY MEETINGS**

2.15.030 Regular assembly meetings. All regular meetings of the assembly shall be held on the second Wednesday of each month; meetings may be preceded by work sessions. Such meetings will be rotated in order among the four (4) major communities of Healy, McKinley Park, Cantwell and Anderson. If the outside temperature is measured to be minus 30 degrees Fahrenheit or colder at any of the four meeting sites, regardless of which site the meeting is scheduled to occur at, the meeting will be cancelled and automatically rescheduled to occur at the same place and time in 7 days, provided no scheduling conflict exists. If a conflict exists the meeting already scheduled will take precedence and the Borough Office will reschedule the cold weather cancelled meeting to a non-conflicting time. An assembly member, planning commission member, or NOAA shall measure the temperature on the scheduled day of the meeting before noon. If the temperature is found to be minus 30 degrees Fahrenheit or below at any of the four locations the information will be communicated to the Borough Office before noon, which will then notify the rest of the assembly and the public to the best of its ability of the cancellation and automatic rescheduling of the meeting. This cold weather cancellation applies to all special meetings, election canvassing, work sessions, committee meetings, and Planning Commission Meetings.

The date and/or location of individual regular meetings may be changed by a majority vote of the assembly, provided such changes are published per DBC 1.050.020. In the event any condition renders the meeting place unfit to conduct any meeting of the assembly, the meeting may be moved to such other place as the assembly may choose, provided reasonable prior notice is given.

Section 3. Effective Date. This ordinance becomes effective upon adoption by the Denali Borough assembly and signature of Denali Borough mayor
