

**Minutes of the Denali Borough
Canvass Committee Meeting
Tri-Valley Community Center
November 9, 2017**

CALL TO ORDER

The Denali Borough Canvass Committee meeting was called to order by Assemblyman Joe CHATFIELD at 6:11 PM.

ROLL CALL

Staff appointed to the canvass committee by Denali Borough Clerk Amber Renshaw were Annette ZIEGMAN, Connie MACMASTER, Marsha LAMBERT and Misty SMART to make a quorum.

A quorum was established with David EVANS, Joe CHATFIELD, Annette ZIEGMAN, Connie MACMASTER, Marsha LAMBERT and Misty SMART. Absent were Don DEBLAUW, Jared ZIMMERMAN, Krista ZAPPONE, Paddy TATUM, Jill BOELSMA, Tallon SHREEVE and Patrick KELLY. Mayor Clay Walker was also in attendance.

QUALIFY QUESTIONED BALLOTS

The canvass committee reviewed the questioned ballot list which included 19 ballots cast.

Connie MACMASTER MOVED to count numbers 1 through 14 on the questioned ballot list. The motion was seconded. The VOTE by show of hands was unanimous.

Connie MACMASTER MOVED to not count numbers 17 through 19 because they are not registered to vote in the Denali Borough and 15 and 16 because they did not register in time for this election. The motion was seconded. The VOTE by show of hands was unanimous.

The accepted questioned ballots which totaled 14 were opened and placed in the ballot box to be tallied with the absentee ballots.

QUALIFY ABSENTEE BALLOTS

The committee reviewed the absentee ballot list provided by the borough clerk. The clerk explained that one of the absentee ballot voters was not registered to vote in the Denali Borough.

Annette ZIEGMAN MOVED to not count ballot number 23 because they were not registered to vote in the Denali Borough. The motion was seconded. The VOTE by show of hands was unanimous.

Joe CHATFIELD MOVED to count ballot 1 through 22. The motion was seconded. The VOTE by show of hands was unanimous.

The absentee ballots were opened by the committee members and placed in the ballot box enclosed in their respective secrecy sleeves.

TALLY QUALIFIED BALLOTS

The qualified ballots were removed from the secrecy sleeves by the borough clerk and placed back in the ballot box. There were 22 qualified absentee ballots and 14 qualified questioned ballots for a total of 36 ballots to tally.

The committee tallied the qualified ballots.

PUBLIC COMMENTS


There were no public present.
