⁽²⁾ Units in excess of the accepted limit should be disposed at the landfill. Commercial units will not be accepted at the transfer stations and will be redirected to the Landfill for disposal at the applicable commercial fee.

Due to the limitations of transport containers at the transfer stations, loads may not exceed five (5) cubic yards in volume and/or eight (8) feet in length. Loads that exceed these sizes will be redirected to the Landfill.

Measuring and calculating formula for trailers or other odd, shaped beds:

Length x Width x Height in feet divided by 27 to obtain cubic yardage, then multiply by \$18.
