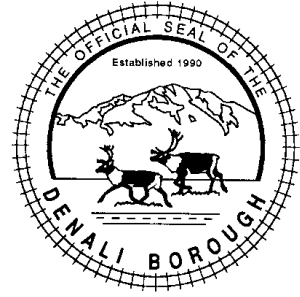

DENALI BOROUGH, ALASKA RESOLUTION NO. 22-20

A RESOLUTION BY THE DENALI BOROUGH ASSEMBLY TO FORM A SPECIAL TRAILS AND OUTDOOR RECREATION PLANNING COMMITTEE TO WORK ON A COMPREHENSIVE TRAILS AND OUTDOOR RECREATION PLAN

WHEREAS, the Denali Borough Land Use and Economic Development Plan includes a land use goal to, “support quality, sustainable front country recreation and tourism”; and

WHEREAS, the Denali Borough Land Management Plan includes a “recreation” classification of borough real property, which is defined as, “real property intended to be retained where the primary use is public and/or commercial outdoor recreation areas and facilities. Recreational uses, include, but are not limited to, trails (non-motorized and motorized), ski areas, golf courses, day use facilities, campgrounds, and wilderness camps”; and

WHEREAS, Ordinance 18-08 established the Department of Parks and Recreation, which includes a subaccount of the General Fund to be used for approved Parks and Recreation activities including, but not limited to, planning, construction, and maintenance of borough parks and recreation facilities”; and

WHEREAS, the Denali Borough has received a technical assistance grant from the National Park Service’s Rivers, Trails, and Conservation Assistance Program to develop a comprehensive trails and outdoor recreation plan; and

WHEREAS, trail and outdoor recreation projects throughout the Denali Borough need to be identified in a community plan to qualify for state and federal grant programs; and


WHEREAS, a special committee to assist in the development of a comprehensive trails and outdoor recreation plan will help expand year-round recreation opportunities in our community to meet increasing demand, as well as diversity and disperse use for both locals and visitors.

NOW THEREFORE BE IT RESOLVED that the Denali Borough Assembly, by this resolution, creates a special committee called the Trails and Outdoor Recreation Planning Committee to assist in the development of a comprehensive trails and outdoor recreation plan.


BE IT FURTHER RESOLVED; that the Trails and Outdoor Recreation Planning Committee shall consist of up to nine (9) members, with the mayor and community development director acting as ex-officio members, and shall continue according to the Denali Borough Code of Ordinances, Chapter 2.45.040 and 2.45.050 including the following guidelines:

- 1.) Seat appointments shall be nominated by the mayor and approved by the assembly.
- 2.) The term of the committee shall commence upon confirmation of seat appointments and terminate upon completion of said project and shall be of a temporary nature.
- 3.) The committee shall produce a final report to the Denali Assembly of its findings and recommendations.
