WHEREAS, the planning commission shall conduct a public hearing in accordance with DBC 9.12.060 prior to taking official actions on any street name change; and

WHEREAS, the attached list of street names is broken down by 2 of the ambulance service areas within the borough; and

WHEREAS, there can be no duplicate street names within an ambulance service area; and

WHEREAS, this resolution is adopting street names in the attached list that are proposed for change because the property owners did not like the previous adopted name, the street name could delay service because of how it is constructed with a gap in the middle, or because of how the address system is setup streets needed directionality prefix; and

WHEREAS, a public notice is posted at the required places per code; and

WHEREAS, the aforementioned list has been reviewed by the Denali Borough Planning Commission.
